Developing the ideas in *How does Living Educational Theory research enable individuals to research into their higher education to improve it and contribute to educational knowledge?* (Huxtable & Whitehead, 2015) presented by Marie Huxtable to the BERA HE SIG meeting on Researching into Higher Education: Innovative Research Methods, 8th May 2015. Introduction

The ideas on innovative research methods in researching the higher education of individuals in the above presentation focused on:

- i) The use of visual data
 - Experiencing living contradiction
 - · Clarifying values
- ii) Empathetic resonance
- iii) Validation
- iv) Transforming writerly into readerly texts.

The Town Hall meeting at the 2015 Action Research Network of the Americas meeting was entitled *Come and join our live conversation with an international community of practitioner action researchers*. Both events took place on the same day, the paper being presented in London, UK and the Town Hall meeting at ARNA in Toronto.

The successful proposal for the Town Hall meeting included:

The intent of this Town Hall meeting is to engage practitioner-researchers across the globe as on site and virtual, through the internet, attendees in a living-culture-of-inquiry through values-based dialogue in creating living-theories (explanations of our influence).

Multi-screen SKYPE conversations are shown to be influencing our perceptions of the idea of Ubuntu that 'I am because we are/we are because I am' or i~we for shorthand and enabling us to 'pool' our life-affirming and life-enhancing energies, as well as sharing and evolving our relationally dynamic culture of inquiry and Living Theory research.

The following reflections might contribute to an emerging research method for Living Theory researchers who are contributing to local, regional, national and global movements to enhance the flow of values and understandings that carry hope for the future of humanity.

Context

I have been a paid member of four action research organisations, the Classroom Action Research Network (CARN - 1976), Action Learning Action Research Association (ALARA - 1990), the Action Research Network of the Americas (ARNA - 2013) and the Action Research SIG of AERA (I joined AERA in 1990) Membership is not cheap. At the business meeting of ARNA in Toronto on the 9th May 2015, I raised the possibility of enabling practitioner researchers around the world to connect freely within events organised by CARN, ALARA, ARNA and the AERA Action Research SIG, through sharing their Living Theory research using living-posters and multi-screen SKYPE.

So, I'm developing my own living-theory as I enquire into enhancing my contribution to the flow of values and understandings that carry hope for the flourishing of humanity. My imagined possibility is to bring into this paper video extracts from SKYPE conversations and the meta living-poster below to see if my action plan makes sense to you as I include information on the kind of data I could collect to enable me to make a judgment on my influence and to evolve my ontological and relational values as explanatory principles in explanations of my educational influence and as living standards of judgment to evaluate the validity of claims to know what I am doing.

The following image represents the kind of experience that is contributing to a shift in my perceptions about relationships and the nature of the values that contribute to the flourishing of humanity. I am thinking of the ontological and relational values that I use to give meaning and purpose to my life. The still image below is from a weekly research support group meeting. The image is similar to the ones from the Educational Journal of Living Theories, editorial and developmental conversations, and the Breakfast Café Conversations on Friday mornings in Bath, UK.

The screen can hold up to 9 individual images, all live and in dialogue. My normal binocular vision cannot hold both the focal and the peripheral images of individuals at the same time. The multi-screen SKYPE images can all be held together. As an individual speaks the image enlarges and appears at the top of the screen, with the rest in a line at the bottom of the screen. I can scan all of the images and feel part of a group, community or network. On the screen below there is Per Jensen who is working in Sweden, Arianna Briganti who is working and researching in Albania, Marie Huxtable, Tammy Nichols and myself from the UK and Teri Young from the USA.




